- C. ALL PERTINENT QUESTIONS MUST BE ANSWERED. WHEN ADDITIONAL SPACE IS NEEDED, ATTACH ADDITIONAL SHEETS. FLOOR PLANS, SKETCHES, PHOTOS
 - NECESSARY TO INSURE ADEQUATE AND COMPREHENSIVE PRESENTATION OF INFORMATION FOR THE BOARD TO REACH A DECISION. <u>EIGHT (8) COPIES ARE REQUIRED</u>.

- F. MEETINGS OF THE CBAZBA ARE HELD IN THE CRESCENT BEACH CENTER, UNLESS THE BOARD ESTABLISHES AN ALTERNATE LOCATION, AT SUCH TIMES AS THE CASELOAD WARRANTS AND THE CHAIRPERSON DESIGNATES.

 ALL PUBLIC HEARINGS WILL BE HELD WITHIN 65 DAYS FOLLOWING RECEIPT
 OF A COMPLETED APPLICATION AND SUBMISSION OF ALL REQUIRED
 DOCUMENTS.
- A NOTICE OF THE CBAZBA DECISION WILL BE SENT BY CERTIFIED MAIL TO THE APPLICANT. A VARIANCE BECOMES EFFECTIVE WHEN A COPY OF THE VARIANCE HAS BEEN FILED IN THE TOWN CLERK'S OFFICE FOR RECORDING IN THE TOWN OF EAST

LYME'S LAND RECORDS. THE APPLICANT MUST INITIATE THIS ACTION.
